ECZEMA RESEARCH & EDUCATIONAL PROJECTS GRANT PROGRAM APPLICATION PACKAGE

Eligibility

Academic researchers based at an academic hospital or university (other than academic research supported by commercial entities) are eligible to apply for an Eczema Society of Canada (ESC) research grant.

Eligible projects should have the aim to improve the lives of Canadians living with eczema, should be educational in nature, and cannot be conducted for profit or to further commercial interests. The results must be for public benefit and must be disseminated. Research and projects which receive funding need to further the charitable objects of ESC.

ESC Board Members are not eligible to apply for a grant during their tenure as Board Members, nor may they directly support an application (e.g., such as providing a letter of recommendation for an applicant) during their tenure as Board members.

Application Details

Application and all supporting documents must be received at the ESC office no later than **September 1st, 2026**.

Introduction

ESC is currently soliciting applications for grants for innovative and focused **eczema research or educational** projects that are consistent with its charitable activities, which include promoting research efforts to gain more knowledge and find a cure for atopic eczema, providing support, information and education to atopic eczema sufferers and their families and enhancing public awareness and understanding about the chronic nature of atopic eczema and treatments. The focus of such projects should be consistent with these objects and include the improvement of care and quality of life for eczema sufferers. Specific areas of focus may include, but are not limited to, atopic dermatitis, hand eczema, and contact dermatitis.

Research and educational project proposals will be considered on scientific merit and impact on the lives of Canadian eczema sufferers and must be in accordance with the ESC objects, mission and ESC Clinical Research Trials Guidelines.

Review Process

All **Eczema Research & Educational Project Grant Program** applications will be reviewed on a competitive basis by the **ESC Research & Educational Project Grant Program Review Committee**. During the review process, the name and institution of the grant applicants are redacted for the purposes of objectivity and anonymity; the identity and institution of referees are however disclosed to reviewers.

Awards

ESC will award and announce grant recipients by email as soon as possible after the selections have been made by sending an award letter. The completed grant application, together with the award letter, the signed Acknowledgement and Certification and the signed Institutional Information forms will constitute the research funding agreement with ESC. The template award letter is found at the end of this application package.

Payment of Funds

All ESC Research Grant Program funds are paid directly to the institutional fiscal officer as indicated in the application. All funds are to be used only for the recipient and project for which the application was made. Surplus funds are to be returned to ESC once the research project is complete, or if the funds are not used, in whole or in part, for the project. All grants represent a single, one-time grant per project, and award amounts may range up to \$25,000. Funds will be paid after receipt of the award letter is confirmed by reply signature.

Publication

If an award is granted, ESC may share publicly, on its website and in other materials and communications intended for eczema sufferers, the Funder's community and the public at large:

- a. the name of the Institution receiving the grant award;
- b. the names of the Principal Investigator and Co-Investigator(s) identified in the application;
- c. the name of the Project, as set out in the completed application; and a brief summary of the Project.

APPLICATION REQUIREMENTS

The 6 documents below must be submitted as one complete PDF document, consisting of **not more than 19 pages in total**.

(1) GRANT APPLICATION FORM (6 PAGES) WITH ACKNOWLEDGMENT, CERTIFICATION, AND INSTITUTIONAL INFORMATION FORM.

Complete the application form, in its entirety, including the acknowledgement and certification form, and the institutional information form. Submit the entire completed 6-page application.

(2) PROPOSAL DESCRIPTION FOR EVALUATION (MAXIMUM 1500 WORDS/6 PAGES)

The applicant names and institutions are blinded. Please do not include applicant names or institutes in this description section or on any headers or footers.

Provide a detailed description of your proposal for review by the ESC Research & Educational Project Grant Program Review Committee, using the format below:

(a) Goals: What are your specific aims? What is your hypothesis?

(b) Significance: What is the significance and relevance of your project to the eczema landscape?

(c) Preliminary Studies: What has already been done in this area? (cite all relevant literature and references)

(d) Methods: How are you going to accomplish your research or educational project? Describe procedures and data analysis in detail.

(e) Timelines: Please include a timeframe for the Project, which includes a start and end date, and target dates for written midterm and final reports, and ongoing financial reporting to ESC.

(3) BUDGET (MAXIMUM 2 PAGES)

Provide a detailed budget of how the funds from the grant will be allocated and disbursed. Include the total project/program budget, and a list of other funding and the names of the funders who are contributing to the project. Indirect costs, such as institutional fees, must be disclosed in the budget.

(4) BIOGRAPHY (MAXIMUM 1 PAGE)

Provide a professional biography (400 word maximum).

(5) LETTER OF RECOMMENDATION (MAXIMUM 2 PAGES)

Submit one letter of recommendation from a supervisor, however not an applicant or co-applicant.

(6) RESEARCH ETHICS BOARD APPROVAL FORM (MAXIMUM 2 PAGES) (IF APPLICABLE)

Submit the final form and/or approval from the Research Ethics Board, if applicable.

4. if the Project is completed under the budgeted amount (less than the total amount of the grant award), or if the funds are not used for the Project, any unused funds are the sole property of and must be reimbursed to ESC.
5. the ESC name, logo, or any identifying marks belonging to ESC will not be used without the express written consent of ESC, including when referencing the application for or receipt of an ESC grant, and (ii) all that any events, communications, or programs, will not interfere or compete with ESC activities.

___ The undersigned hereby certify that the statements in this application are true, correct, and complete to the best of my/our knowledge.
